| <p>Active-Duty Military Personnel Permanently stationed in the State of Georgia. Dependent may continue in this status if sponsor is transferred so long as student remains <u>continuously</u> enrolled at AASU. <i>Includes spouse/dependent children</i></p> <p>*Must be renewed upon expiration of military ID on file.</p> | <ul style="list-style-type: none"> • Copy of military orders affirming permanent station in the State of Georgia • Copy (front and back) of active-duty military ID • <u>Dependents</u> must provide a copy of their dependent military ID |
| <p>Former Active-Duty Military Must have retired or otherwise separated from active duty within 12 months of first term of enrollment at AASU. <i>Includes spouse/dependent children</i></p> <p>*Nonrenewable—valid for one year only.</p> | <ul style="list-style-type: none"> • Copy of DD214 • Copy of current lease or warranty deed • Copy of Georgia driver's license • <u>Dependents</u> must also provide federal income tax form indicating dependent relationship. |
| <p>Economic Advantage Moved to Georgia to accept full-time, self-sustaining employment and established domicile in the State of Georgia <i>Includes spouse/dependent children</i></p> <p>*Nonrenewable—valid for one year only.</p> | <ul style="list-style-type: none"> • Letter from employer verifying start date of permanent, full-time employment • Copy of current lease or warranty deed • Copy of Georgia driver's license • <u>Dependents</u> must also provide federal income tax form indicating dependent relationship. |
| <p>Full-time Employee of Georgia Public Schools or Department of Technical and Adult Education (includes schools on Georgia military bases) <i>Includes spouse/dependent children</i></p> <p>*Expires June 15. May be renewed annually.</p> | <ul style="list-style-type: none"> • Certification of full-time employment from the human resources department of the employing institution <u>or</u> copy of teaching contract • <u>Dependents</u> must also provide federal income tax form indicating dependent relationship. |
| <p>Full-time Employee of University System of Georgia <i>Includes spouse/dependent children</i></p> <p>* Expires June 15. May be renewed annually.</p> | <ul style="list-style-type: none"> • Written certification of full-time employment from the human resources department of the employing institution. • <u>Dependents</u> must also provide federal income tax form indicating dependent relationship. |
| <p>Active-Duty Member of the Georgia National Guard <i>Includes spouse/dependent children</i></p> <p>*Must be renewed upon expiration of military ID on file.</p> | <ul style="list-style-type: none"> • Military orders affirming status in Georgia National Guard <u>or</u> letter from commanding officer • Copy (front and back) of military ID card • <u>Dependents</u> must also provide a copy of their dependent military ID card. |
| <p>Dependent of a Georgia Citizen Spouse/dependent child of a Georgia Citizen</p> <p>*expires June 15. May be renewed annually.</p> | <ul style="list-style-type: none"> • Copy of Georgia income taxes (Form 500) indicating dependent relationship • Copy of lease or deed of spouse/parent • Copy of marriage certificate, <u>if needed</u> • Copy of immigration paperwork, <u>if needed</u> |
